

Assistive Technology Scholarship Terms and Conditions

By submitting an entry, all entrants will be deemed to have accepted these terms and conditions, and agree to be bound by them. Please read them carefully before you submit your entry.

1. The scholarship is jointly run by the following companies (the "Donors") which have each offered to donate their products and/or services to the successful entrants: LEXABLE LTD. (06284793), TEXTHELP LTD. (NI031186), MATCHWARE LIMITED (03227036), SONOCENT LTD (06127874), LEARNING LABS (UK) LTD. (08561333) AND DIVERSITY AND ABILITY LTD (07525234).
2. There is a maximum of 10 scholarships available per year. Each successful entrant will be provided with the following assistive software packages: Global AutoCorrect, Read and Write, Mindview and Audio Notetaker and 3 years access to Learning Labs (the "Software"). The Software will be delivered to successful entrants via a download link, serial number and/or login details as appropriate. Additionally, each successful entrant will be provided with 6 hours of remote training from one of the Donors, Diversity and Ability Limited (the "Services").
3. Use of the Software and Services by successful entrants is subject to any user terms and conditions that may apply to them. Updates to the Software may be provided at the discretion of individual Donors.
4. Only one entry per person is permitted each year. Group entries (for example, on behalf of a school) are not permitted and will be disqualified.
5. Awarding of scholarships is based on the passion, creativity, merit and need demonstrated by each entry, and is entirely at the discretion of the Donors. Each decision is final and no correspondence will be entered into in respect of any decision made.
6. The Software and the Services together constitute the scholarship. No other financial support or cash alternative is available and each Donor's liability to each successful entrant is limited to the retail price of the particular software and/or service that they have offered to donate. Each Donor is separately liable for the provision of the product and/or service that they have individually offered to provide to successful entrants and any problems or issues that may subsequently arise with the product and/or service that they have provided. For the avoidance of doubt, LexAble Limited, as administrator of the scholarship, is not responsible for ensuring that the other Donors provide any of the products and/or services that they may have individually offered to provide to successful entrants.
7. Successful entrants will be notified in writing within 90 days of their submission.
8. The scholarship is non-transferable.
9. The Donors reserve the right to amend these terms or close the scholarship without prior notice at any time.
10. Successful entrants may be asked to take part in publicity by the Donors without remuneration. As a minimum, the Donors will be entitled to publish the first name, county and country of those successful entrants.
11. Any entries that may infringe the intellectual property rights of another party (for example, if an entry uses the work of somebody else) will be disqualified.
12. LexAble Limited is responsible for collating all of the entries for consideration by the Donors. By submitting an entry or otherwise sharing personal data with LexAble Limited, each entrant agrees that LexAble Limited may share this data with the other Donors. The data will be used only for the purposes of administering the scholarship and will not be used for marketing purposes.
13. Nothing in these terms and conditions is intended to exclude or limit any Donor's liability to the extent that it is unable to by law, for example for death or personal injury caused by a Donor's negligence or any loss caused by a false statement where the statement is made fraudulently. Each Donor fully accepts any liability for these matters and all matters for which it cannot, under English law, exclude or limit its liability.
14. The scholarship (and any dispute or claim arising out of it) shall be governed by and construed in accordance with English law and the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with it.
